#### January 28 – Dick Shelton – The Edict of Torda

The 500th anniversary of Luther's Theses at Wittenberg fell in 2017, and the 450th anniversary of the Edict of Torda falls in 2018. The 50 years intervening between Wittenberg and Torda witnessed a revolution in the cultural and spiritual life of Europe and Western Civilization. The Edict of Torda, promulgated in the unlikely province of Transylvania, has become one of the defining moments of Unitarianism, and while modern UUs have attached a rather overly-heroic mythology to that event, it remains a

remarkable moment in the history of religious freedom -- one whose lessons we are still fighting to realize even today. This program examines the background that led to that moment, and what it really meant in the context of the religious upheaval in Europe of the 16th century and beyond.

#### RICE CREEK COMMONS

Matthew Bachler, Arden Hills city planner, has provided the following summary of the master plan and current development progress for the former munitions site north of Highway 96 west of Pilgrim House. The highlighted items are questions that Mina Adsit asked him to address. If enough Pilgrim House members are interested in the project, Matthew would present at a weeknight meeting at Pilgrim House.

# **Summary Of The Master Plan And Method Of Development**

The City began the planning process for the Rice Creek Commons development in 2013. A consultant team comprised of Kimley-Horn, Cunningham Group, and Gateway Planning was hired to develop the master plan, Alternative Urban Areawide Review (AUAR), and development regulations. The City held several public meetings, met with stakeholders, and solicited input from developers representing different industry sectors in developing the master plan. A few of the goals for the redevelopment identified by the community included having well-defined residential neighborhoods, a mix of housing options, abundant park space, a trail system

linking neighborhoods and commercial areas, and highquality commercial development and amenities.

The master plan was approved by the City in 2015 and was recently updated in December 2016 based on proposed amendments by the master developer, Alatus LLC. The master plan includes:

- · 146 acres of land for residential uses
- · 34 acres of land for retail uses
- · 100 acres of land for office and light industrial uses
- 16 acres of land for the "Town Center" that will include a mix of residential, retail, restaurant, and entertainment uses
- · 24 acres of land for City parks and open space

# Proposed Housing Mix Including Workforce/Affordable Housing Components

The master plan and development regulations for the site support a wide range of different housing types, including single-family residential, twin homes, townhomes, multi-family residential, and senior housing. Based on the development regulations, a maximum of approximately 1,460 housing units could be constructed in the development. The City has adopted a goal that ten percent of all new housing units on the site should be affordable to households earning 80 percent or less of area median income as established by the Metropolitan Council.

### **Environmental Impact Of The Development And Green Space Set Asides**

As part of the planning process, an Alternative Urban Areawide Review (AUAR) was completed for the redevelopment area. The AUAR process is a hybrid of an Environmental Assessment Worksheet and an Environmental Impact Statement. The AUAR looks at the cumulative impacts of anticipated development scenarios within a given geographic area. It can be used as a planning tool for cities to understand how development will affect the environment before development occurs. Areas examined include geology, soils, and topography; water resources; contamination and hazardous materials; fish, plant communities, and sensitive ecological resources; historic properties; visual; air; noise; transportation; and cumulative potential impacts. The completed AUAR includes a mitigation plan with actions that are advisable, recommended, or necessary to protect the environment and minimize potential impacts of development. The findings in the AUAR were incorporated into the master plan and development regulations for the site.

The master plan includes 24 acres of land set aside for City parks and open space. It is anticipated that the developer will include additional small open space areas within the residential neighborhoods. The site also includes approximately 45 acres of land that would be kept as open space and used for regional stormwater management purposes.

#### **Environmental Cleanup Requirements**

The 427-acre redevelopment area has been cleaned to residential standards and the Minnesota Pollution Control Agency has issued a Certificate of Completion for the soil remediation work. The U.S. Army will continue to operate the existing groundwater cleanup system for many years to come. The groundwater contamination will have no impact on the Rice Creek Commons development as the City provides drinking water to residents from St. Paul Regional Water Services

#### Benefit to the City of Arden Hills

The Rice Creek Commons project will have numerous benefits to the City, including but not limited to:

- Returning the land to productive use
- Cleaning up the state's largest Superfund site
- Stimulating regional economic development and creating high wage jobs
  - Add to the local property tax base
- Providing a variety of housing options that address affordability and life-cycle needs

#### **Current Project Status**

Representatives from Ramsey County, Arden Hills, and Alatus spoke with the Army in mid-November about the optimization study underway at the Twin Cities Army Ammunition Plant (TCAAP), now referred to as the Rice Creek Commons development. The study is examining how to best continue to treat the groundwater on the site. The Army shared that the study will not be released until the first quarter of 2018. Their consultant's initial fieldwork resulted in the need to conduct a more detailed evaluation, which has caused this delay. The Army did not disclose any initial findings from the study to date.

The development was included as a possible site in Minnesota's regional bid for Amazon's second headquarters. Amazon is seeking a 100-acre site, which would take up less than one-fourth of the full 427-acre Rice Creek Commons site. Amazon is not expected to select a final site until 2018.

In the meantime, Ramsey County, the City of Arden Hills, the Joint Development Authority, and Alatus continue to move forward with a mixed-use development as originally planned. Infrastructure development (roads, sewer, water treatment, etc.) is expected to begin in 2019, and houses could begin to be constructed as early as 2020.
