

September 25 – Neither Wolf nor Dog

Ken Nerburn is the author of Neither Wolf nor Dog which was turned into a movie. One white man and one Dakota locked in their own understanding yet struggling to find a common voice. It was the winner of the 1996 Minnesota Book Award. He is co-founder of Schoolcraft Learning Community has a PHD in Religion and Art. He is deeply involved in Indian Traditions, and is the author of many books. He said "obviously only for ZOOM unless, by some strange circumstance (and the world is full of strange circumstances) I happen to be back in the Twin Cities."





October 2 - Where do we come from?

This overview of Unitarian and Universalist history will cover the evolution of ideologies in these two denominations. Rev. Leslie Mills is a third generation Unitarian Universalist. She was dedicated as a child at First Unitarian Society in Milwaukee, and went through Coming of Age at Unitarian Church North in Mequon, Wisconsin. After college, she joined the Unitarian Universalist Church of Rockford, Illinois, where she felt called to ministry. After exploring the 12 UU churches in the Twin Cities during seminary, she was called to serve the Unitarian Universalist Church of Elgin, Illinois, where she was ordained in 2016.



COMMON READ ON A NATIVE AMERICAN TOPIC--

Coordinated by Connections Committee

In conjunction with the September 25 program at Pilgrim House that will be presented by author Kent Nerburn, the Connections Committee is organizing a Common Read of one of his books, *The Wolf at Twilight*, followed by a book discussion in **October**. There's time to check your library or bookstore -- and we will acquire a few copies to rotate among readers at Pilgrim House. Plan to join us for this discussion.

Summary: A note is left on a car windshield, an old dog dies, and Kent Nerburn finds himself back on the Lakota reservation where he traveled more than a decade before with a tribal elder named Dan. The touching, funny, and haunting journey that ensues goes deep into reservation boarding-school mysteries, the



dark confines of sweat lodges, and isolated Native homesteads far back in the Dakota hills in search of ghosts that have haunted Dan since childhood.

SACRED SITES TOUR ON AUGUST 21



Pilgrim House UU, along with friends from the Groveland UU Fellowship and Michael Servetus UU, spent Sunday afternoon visiting sites sacred to local indigenous peoples around the confluence of the Minnesota and Mississippi rivers near Fort Snelling. Rev Jim Bear Jacobs, Co-Director for Racial Justice for the Minnesota Council of Churches, conducted the tour for over 40 participants. Pictured above is a lecture area marking where a stockade had confined some 1700 indigenous people in the 1800's. We also visited

Pilot Knob, a sacred indigenous burial site nearby. Jim Bear can be seen presenting in the pictures. I think all will agree it was a powerful experience, albeit with sometimes-difficult messages that are important to be heard ... a highly-recommended experience.

GENERAL ASSEMBLY REPORT

As this year's PH delegate, I was one of approximately 1,900 people attending the hybrid UUA (Unitarian Universalist Association) General Assembly (GA) virtually last June. Another 1,300 or so were on-site in Portland, Oregon.

The Assembly's theme was "Not Business as Usual." There was a very full agenda, with multiple live and taped workshops available online (see https://www.uua.org/ga/off-site/2022).

Speakers introduced themselves with their pronouns, the native land on which their congregations are located and described their physical appearance for those who may be visually impaired. Many of the speakers and preachers were people of color and/or young people.

In addition to Board elections (Susan Frederick-Gray continues as President) and approving the budget, a proposal to rewrite the bylaws was one of the items on the agenda. The case was made that the static and often confusing procedures that characterize many organizations' bylaws and meeting rules flow from, and continue to support, a culture based in white supremacy. (The 2021 Assembly passed a Statement of Conscience entitled "Undoing Systematic White Supremacy: A Call to Prophetic Action" https://www.uua.org/action/statements/undoing-

https://www.uua.org/action/statements/undoingsystemic-white-supremacy.) The proposal to rewrite the bylaws is intended to make decision-making more transparent and ensure active efforts and accountability to UU values. The UUA is also working on new ways to convene gatherings that rely more on consensus than majority voting.

The importance of clarifying and using values to define mission, guide collective action and promote accountability was repeated throughout the conference. A speaker observed that, because Unitarian Universalists don't have a canon, it can continue to evolve and respond to current societal issues and challenges. But, as a result, it is important that there be a shared sense of values among its members. An in-depth review of UU values is part of the nationally convened Bylaws Article II Study Commission's work, the results of which will be presented to congregations for approval in 2024. (See

The 2022 GA also affirmed the following "Actions of Immediate Witness:

- AIW 1: We Do Not Consent: Rejecting Legal Challenges to Abortion
- AIW 2: Anti-Racism and Reparations
- AIW 3: Stop Privatization of Medicare

I continue to be impressed by the UUA's efforts to be critically self-aware, as well the variety of activities in which the UUA engages and the resources available to member congregations. This includes some original music that was performed live as part of the 2022 GA programming.

Next year's conference will be in Pittsburgh, and will be hybrid.

HOW ARE MN UU'S WELCOMING REFUGEES AND NEW IMMIGRANTS? SOME EXAMPLES:

From an email from MUUSJA:

UU's across Minnesota teamed with the 3 federally funded resettlement agencies in our state (Alight, Lutheran Social Services, and Catholic Social Services) in a variety of ways and created congregational teams to fill ongoing needs.

First Unitarian Society (Minneapolis) committed to assist 10 families being resettled by Alight in Minneapolis. Several congregations, including the Saint Cloud and Minnesota Valley (Bloomington) fellowships, invited speakers from Alight to their

Sunday services and contributed financial donations to Alight (http://wearealight.org/).

White Bear WBUUC Hazara Assistance Committee is assisting three Afghan refugee families in Minneapolis and one in St. Paul as they continue to settle into life in Minnesota since leaving their homeland suddenly last August. They're inviting volunteers short term in one of several capacities -giving a ride once a month for a family of four, take a 19 year-old to a community college to visit, or visit with three young women living together in St. Paul. The UU Congregation of Duluth teamed with the Interfaith Committee for Migrant Justice of the Twin Ports for World Refugee Day on Monday, June 20, 2022 from 5 - 7 pm at 12 E. 4th St (One Roof Community Housing) to welcome asylum seekers, refugees, and migrants into the Duluth community which is situated on Anishinaabe Territory. The most

Unity Unitarian (St. Paul) donated the plate on January 2, 2022 to the International Institute of Minnesota Afghan Refugee Program and hosted an exhibit by Emel Sherzad, successful artist, former Afghan refugee, and owner of the Khyber Pass Cafe in St. Paul. He has a compelling life story and shared about his powerful paintings on display in the Parish Hall.




Ivory Coast, Nigeria, Afghanistan and Venezuela.

First UU Church in Rochester formed a Refugee Services Team who've worked with folks in their community resettled by Catholic Social Services (which holds the contract for southern MN). Michael Servetus UU Fellowship (Fridley) and Minnetonka UU Church (Wayzata) teamed up to sponsor and support a Guatemalan refugee family. First Universalist (Minneapolis) has a new team considering how best to accompany an Afghan refugee family in addition to ongoing sanctuary and resistance work with ICOM and south Minneapolis sanctuary network.
